CHARTER FROM THE MUNICIPALITY OF CAXIAS DO SUL AND SERRA GAÚCHA REGION

Convinced that people today seek in the job market a perspective of a sustainable future, based on accepted values and with an awareness of the causes of underlying events and with a vision of the future not only local, but also global, and with the intent to open space as described above for the municipalities of Brazil, we propose to the Union, the State, the Municipalities, the supporting International Foundations and the Banks that, the segments of Education, Housing, Culture, Development, Agricultural and Industrial, Health, Environmental, Urban Planning, Security and Basic Sanitation support and encourage the execution of projects, prioritizing the following:

- That resources from international bodies and banks be allocated directly to the Municipalities, as each Municipality is aware of its reality and has its particular problems and priority works;
- That Sister Cities International participates effectively with municipalities in Brazil;
- That customs procedures and the receipt of donations are reduced from bureaucracy;
- That the Brazilian government supports the receipt of donations for public health, civil defense, vehicles, machinery, agricultural equipment and highways and IT equipment for education;
- That there be strengthening and appreciation of municipalism;
- That tourism is encouraged;
- That rural people have the necessary conditions to produce, live and professionalize;
- That children, adolescents, and seniors have specific programs;
- That micro river basin programs are valued as well as exchanges between municipalities, states, and countries;
- That there be priority in the transfer of resources to agricultural and popular housing funds already established in municipalities, or to programs in these areas;
- That the creation of sister cities and their programs be encouraged;
- Establishment of diplomatic cities.

EXPLANATORY MEMORANDUM

Madam President, Ladies and Gentlemen Councilors,

Created in 1956 in the United States, the concept of sister cities aims to promote economic, cultural, educational, scientific, technological and social development among municipalities around the world.

Today, thousands of cities in over 120 countries participate in the program, which was initiated by the United Nations (UN). The fundamental principle of the program is to establish an exchange of experiences and establish partnerships that result in improving the quality of life of the inhabitants of both municipalities.

The search for alternatives that can help overcome the problems faced by a municipality is more promising if there is the possibility of dialoguing with other municipalities or regions that face similar problems.

In general, two cities are declared to be sister cities when there are factors that bring them together in some way, such as common historical references, shared cultural traditions, relative geographic proximity, and convergence of economic, commercial, academic, and scientific interests.

Among the mutual benefits commonly inherent in city twinning, one can mention the facilitation of cultural, academic, and professional exchange, cooperation in the development of public policies, and the strengthening of commercial and tourism relations between both cities, contributing to social development and local integration with other parts of the world.

This bill aims to establish a legal framework that allows the formalization and development of partnerships between the Municipality of Caxias do Sul and sister cities, with the aim of promoting cooperation, the exchange of experiences, and the strengthening of international relations.

The creation of a clear and comprehensive regulatory framework will provide an environment conducive to establishing collaborations in various areas of mutual interest, contributing to the social, economic, and cultural development of the city.

BILL No. 78/2024LAW NO..., OF..., OF OF....

Provides for the establishment of partnerships between the Municipality of Caxias do Sul and Sister Cities, and other measures.

- Art. 1 The concept of "sister cities" is hereby established within the scope of the Municipality of Caxias do Sul, comprising cities from different nations that, through a formal agreement, seek to strengthen ties of cooperation, cultural, educational, economic and social exchange.
 - Art. 2 Sister cities may enter into cooperation agreements involving, among other possibilities:
 - I. Cultural exchange: promotion of cultural events, festivals, exhibitions, artistic presentations, among others, aimed at spreading culture and strengthening relations between cities;
 - II. Educational exchange: establishment of exchange programs for students, teachers and researchers, with a view to exchanging knowledge and academic experiences;
 - III. Economic cooperation: development of initiatives to stimulate trade, investment, tourism and business exchange between cities;
 - IV. Partnerships in social projects: collaboration in projects aimed at sustainable development, promoting human rights, combating poverty and social inclusion;
 - V. Cooperation in health and environment: exchange of experiences and information in areas such as public health, environmental protection, basic sanitation and waste management;
 - VI. Sports exchange: promotion of sports events, tournaments, competitions and exchange of athletes and sports teams;
 - VII. Technical and scientific cooperation: joint development of research, technological and scientific projects of mutual interest.
- Art. 3 The Municipal Government shall seek, encourage and support mechanisms for integration between the inhabitants of both cities covered by this Law, including facilitating the flow of people between them.
- Art. 4 The twinning agreement covered by art. 2 of this law has the following basic objectives, among others:
 - I the pursuit of progressive strengthening of relations (cultural, educational, commercial and others) between the populations of both cities, as well as between their respective countries:
 - II the exchange and sharing of information, knowledge and experiences regarding public policies and topics of interest to the community in general, especially in the areas of education,
